**Investiture of the title “Honorary Alderman”**

**Report of the Assistant Director of Governance and Monitoring Officer**

This report is public

**Purpose of the Report**

To seek members’ approval to confer the title Honorary Alderman on former councillor Raymond Brooks. This is in view of the 25 years plus service he gave to Bolsover District Council and Blackwell Rural District Council.

**Report details**

- 1.1 The Local Government Act 1972 - Part 2, Section 249 gives the Council power to confer the title of Honorary Alderman on persons who have, in the opinion of the Council, rendered eminent services to the Council as past members of the Council, but who are not then councillors of the council. The service can include that of former borough, urban or rural district councils.
- 1.2 The resolution must be made at a meeting specially convened for the purpose and be passed by not less than two-thirds of the members present and voting.
- 1.3 An Honorary Alderman may attend and take part in such civic ceremonies as the Council may from time to time decide. However, there is no right to attend meetings or receive any allowance.
- 1.4 The Council has a policy of conferring the title of Honorary Alderman on any former elected member who has undertaken 25 plus years of service as a local elected member with the District of Bolsover or its predecessors (Blackwell Rural District Council, Clowne Rural District Council or Bolsover Urban District Council) or has given eminent service to the Council.

**2 Conclusions and Reasons for Recommendation**

- 2.1 Former councillor Raymond Brooks has served for more than 25 years, taking account of his length of service on Bolsover District Council and a predecessor council. The award of the title is therefore within the Council’s policy.

### **3 Consultation and Equality Impact**

3.1 There are no consultation requirements or equality issues.

### **4 Alternative Options and Reasons for Rejection**

4.1 Not to award the title. This was rejected as it was felt that the Council would want to honour its former elected member and the award fits within existing policy.
