

Notice is hereby given that Bolsover District Council ("the Council") has made the Bolsover District (Sookholme Road, Shirebrook)Public Spaces Protection Order No.1 of 2015 under s 59, 64 and 72 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act"):

1. This Order relates to that part of Footpath 18 to the rear of Sookholme Road Shirebrook as shown coloured blue on the attached Plan ("the Restricted Area").

2. The Order came into force on 2015 for a duration of 3 years.

3. The effect of this Order is to restrict the public right of way over the Restricted Area at all times

4. This Order authorises the installation of fencing and a gate

5. The alternative route for pedestrians will be along Long Lane and Sookholme Road.

6 Any person found on the Restricted Area without the consent of the Council shall be guilty of an offence under section 67 of the Act and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale or fixed penalty notice of a maximum £100.

At the most recent meeting of Shirebrook Town Council certain issues were raised that require attention.

FOOTPATH 18 – SHIREBROOK

Local residents are becoming increasingly frustrated by the issues that they are facing on a daily basis in relation to the anti-social and criminal use of this footpath and have asked for our assistance in resolving these issues.

We at the Town Council have grave concerns for the welfare of local residents as result of the anti-social behaviour occurring along this path including drug use, and related paraphernalia, other waste and hazardous substances and the access this path allows to the rear of their properties has enabled thefts/burglaries.

Historically this path was well used by workers from Shirebrook Colliery, however it would now appear that the only users of the path are those using it for illegitimate reasons. We are therefore investigating the plausibility of this footpath being extinguished or redirected.

We would welcome your assistance with the progression of the above.

GRASS CUTTING SCHEDULE AND STANDARDS

We are receiving an increasing number of complaints in relation to the standard of grass cutting that is being delivered in Shirebrook. Whilst we appreciate that the weather has played a part in delays and frequency of cuts, Councillors still feel that better management and scheduling of grass cutting procedures need to be implemented to rectify current issues.

Could you please help myself and other residents of Sookholme Road, Shirebrook [Names and addresses can be provided at any time they are required].

Directly behind our properties there is a footpath that for many years has been allowed to become overgrown and neglected. When the banking was built up behind the properties and sportworld came to Shirebrook some people that came to work there have been using the footpath since to cause anti – social behaviour. This includes:-

Drinking and shouting behind our properties, constantly,

Throwing used cans etc over onto our gardens,

Breaking into garages, outbuildings etc,

Eating and disgarding litter,

Urinating/soiling behind our properties, basically living there, One occasion throwing a pitchfork over an approx. 6/8ft wall, with no regard for the people/dog on the other side,


Being used as a drop off point for things that I can only presume have been stolen from sportsworld (judging by the number of empty boxes that are sometimes out there),

Items ,money being left in carrier bags then other people picking them up.

People taking photographs over 6/8ft high walls at the rear of our houses with no regard for our privacy.

These are some of the many things that are happening over what seems like an endless timescale. We all report these as we have been told to many times by our local councillor Mr Brian Murray Carr, the local PSCO's, and the local sergent here at Shirebrook. This must therefore mean that numerous police man hours are used on matters like this. (I would go as far as to say it is harassment}.

At one stage Mr Murray Carr suggested that there was a possibility that the footpath be gated off for residents use only, to gain access to properties/garages. Two other entry/exit sites to footpath 28 have already had large concrete pipes put over them and been allowed to become or nearly become on one of them totally impassable, by whom I am unsure. Surely if it can be done (and obviously the council have no objections as this has been done at two other entry/exit sites), then WHY can something not be done at the other end behind us, to stop all this anti social behaviour, wasting of police time/man hours and stress to us all. Please could you help?
