Bolsover Regeneration Frameworks Procurement

Report of the Assistant Director Economic Growth

This report is public

Purpose of the Report

- To seek Members' approval for tendering for the Regeneration Frameworks for Bolsover district and appointing consultants for these, based on the brief prepared by the Enabler.
- To approve an additional £20,000, as a contingency fund in addition to the existing budget allocation of £90,000 for production of the Regeneration Frameworks.

1 <u>Report Details</u>

- 1.1 On 02 March 2015, the Executive approved the Joint Economic development and Housing strategy for Bolsover district, which also approved the allocation of £90,000 from the Transformation Reserve for the production of four Regeneration Frameworks for the District.
- 1.2 Of the £90,000, a budget of £10,000 was set aside for appointing an "Enabler" to carry out an enabling function to facilitate the regeneration frameworks by providing support and guidance to secure optimum results from the main body of work (i.e. the regeneration frameworks); the latter will be undertaken under contract by one or more multidisciplinary professional teams procured by competition. Enabling tasks include brief formulation and advice on the procurement of consultants to produce the frameworks, with provisional further input of overseeing the work of the consultants. In July 2015, Tom Lonsdale of Placecraft was procured as the Enabler.
- 1.3 The remaining budget of £80,000 has been ring fenced for the main consultancy work to produce the frameworks. However, initial work undertaken by the Enabler suggests that the budget may not be sufficient to cover the 4 town; therefore, approval is sought for a further allocation of £20,000 (to cover the 4 towns) as a contingency fund.
- 1.4.1 The principal characteristic by which this work (i.e. the frameworks) will distinguish itself from earlier reports such as the 2008 Bolsover Regeneration Strategy will be its focus on quality of place; the consultants appointed will be required to evaluate

each place and develop recommendations, working through the following sequence:

- Observation
- Enquiry (desk study and engage with community and stakeholders)
- Identification of decay and malfunctions
- Generate ideas/opportunities for treatment (repair, replace, conserve etc.)
- Consult and debate (engage with community and stakeholders)
- Scope out actions and resources required to achieve preferred options
- Develop action plan and monitoring
- 1.5 It is intended that the spatial elements of the Frameworks will form part of the Local Plan.
- 1.6 Owing to the complexity of each framework, 2 consultancy firms/ consortiums will be procured to cover 2 towns each, as follows:
 - 1.6.1 Consultancy Commission 1:
 - 1.6.1.1 Focussing on Bolsover Town Centre and including Bolsover South, West, Scarcliffe, North West
 - 1.6.1.2 Focussing on Clowne Town Centre and including Clowne South, North, Whitwell, Barlborough, Elmton with Creswell
 - 1.6.2 Consultancy Commission 2:
 - 1.6.2.1 Focussing on Shirebrook Town Centre and including Shirebrook North West, South West, South East, East Langwith, Pleasley
 - 1.6.2.2 Focussing on South Normanton Town and including South Normanton East, West, Blackwell, Tibshelf, Pinxton
- 1.7 Each of the commissions/ contracts is expected to be in the region of £40,000 £50,000, equating to a total contact value, upto a maximum of £100,000 for the 4 frameworks, as detailed above. The initial briefs will go out to tender with a value of £40,000 each specified.
- 1.8 As detailed above, one of the key roles of the Enabler is to produce a brief to enable the procurement of consultants and guide the regeneration framework process, which is appended for approval.

2 <u>Conclusions and Reasons for Recommendation</u>

- 2.1 The Regeneration frameworks will be crucial in terms of prioritising future regeneration work in the district by creating a basis for targeted and coordinated public sector intervention to address market failure affecting people and places.
- 2.2 As suggested by the Enabler, the frameworks will enable the regeneration of the district via "the nurture of natural regrowth by careful pruning of redundant and unhealthy fabric and building towards a healthy and robust, sustainable organism/entity."

- 2.3 The frameworks will address the key priorities identified in Joint Economic Development and Housing Strategy and will be the basis for work undertaken by the economic development team and future public funding opportunities.
- 2.4 The allocation of additional £20,000 contingency funds will ensure a robust budget to undertake a complex initiative in a comprehensive manner, involving extensive public consultation.

3 Consultation and Equality Impact

- 3.1 On 04 August, Cabinet met with Enabler, Tom Lonsdale; informal discussions were held around procuring 2 frameworks for Clowne and Bolsover as one and Shirebrook and South Normanton as another; also discussed was the requirement for an additional £10k for each commission as a contingency fund.
- 3.2 A stakeholder and community engagement action plan will be produced in consultation with the consultants following their appointment, which will support the development of the regeneration frameworks.

4 <u>Alternative Options and Reasons for Rejection</u>

- 4.1 Option 1: Undertake the frameworks within the existing budgets of £80,000, without any further budgetary allocation: limiting the budget for consultancy work could compromise on the quality of work produced and could result in omissions of crucial elements of work, which cannot be quantified at this stage (without undertaking the consultant procurement); therefore this option is not recommended.
- 4.2 Option 2: Not undertake the regeneration frameworks: will be a missed opportunity to undertake a crucial piece of work underpinning all future regeneration and economic activity in the district, therefore this option is not recommended.

5 <u>Implications</u>

5.1 <u>Finance and Risk Implications</u>

An additional contingency budget allocation of £20,000 is requested to be available for the regeneration frameworks, should the need arise.

6 <u>Recommendations</u>

- 6.1 To approve an additional £20,000 (£10,000 for each commission) as a contingency fund, to sit alongside the approved budget of £90,000 for the Regeneration frameworks.
- 6.2 To endorse the brief Appendix 1 produced by the Enabler, which will be the basis for procurement and appointment of consultants for producing the frameworks, as detailed above.
- 6.3 To procure 2 consultancy firms or consortiums to produce 4 regeneration frameworks for Clowne and Bolsover as one and Shirebrook and South Normanton as another.
