Electrical works to Dwellings for Bolsover District Council

Report of the Portfolio Holder for Housing and IT

Purpose of the Report

 To seek approval for the awarding of the contract for Electrical Works in Council Owned domestic properties for Bolsover District Council

1 Report Details

- 1.1 It was identified that a new contract was required for Electrical Works in Council Owned domestic properties for Housing in accordance with current procurement Guidelines.
- 1.2 Efficiency East Midlands were in the process of drawing up a new Framework for the regional provision of Electrical works of which Bolsover District Council are members and as such were able to make significant input to the tender specifications, which ensured that the tender was open to a large number of contractors helping to ensure that Bolsover District Council benefited from a competitive tender.
- 1.3 After evaluation by Efficiency East Midlands and members of the Framework, including Officers from Bolsover District Council, six Contractors were identified for the Nottinghamshire/ Derbyshire region Framework.
- 1.4 The Framework incorporates the requirements of all the individual Authorities which are members, and as such contains a large selection of items that Bolsover District Council do not currently use. Therefore further evaluation, based on a basket of goods approach for items frequently used by Bolsover District Council, was carried out to determine a more suitable Contractor from the six recommended. This stage of the evaluation was based on costs only as quality had already been assessed to place the contractors on the EEM framework,

This evaluation gave the following outcomes

As a result of this further evaluation, Housing is seeking approval to award the contract, within the Framework to PK Electrical Ltd.

1.5 The Framework offers flexibility to approach any of the other five contractors should the need arise due to operational demands which is highly beneficial in terms of maintaining service provision.

2 Conclusions and Reasons for Recommendation

2.1 It is recommended that the framework contract be awarded to PK Electrical Ltd as for the duration of the four years that the Framework is in force. If demand for work exceeds the capacity of PK, some work may offered to other contractors on the framework (based on lowest cost) without the need for further tendering.

Based upon this evaluation we anticipate savings of 10% will arise from the new contract, as against current arrangements.
