Asbestos removal to Pattison Street Shuttlewood in connection with the re-roof programme of works utilising the Efficiency East Midlands (EEM) Framework

Purpose of the Report

 To seek approval for European Asbestos to remove asbestos containing soffits to Pattison Street flats in connection with the re-roofing programme utilising the Efficiency East Midlands (EEM) framework after they successfully bid for the works through an EEM mini tender process.

1 Report Details

1.1 Prior to the re-roofing programme starting at Pattison Street flats earlier this year the mandatory asbestos surveys identified the presence of Amosite within the soffits of the roof. Amosite has to be removed by a licensed asbestos removal contractor and as such estimates were requested to determine an initial cost. Upon receipt of these quotes it became apparent that because of the substantial value of the works a formal procurement process would have to be sought. EEM were approached as they had an existing framework of 4 contractors in place for the licensed removal of asbestos. A mini tender process was carried out and following evaluation, the successful bidder was European Asbestos.
