## **Report on Rural Economic Prosperity Fund**

#### PURPOSE/SUMMARY OF REPORT

This report seeks the agreement of Executive to accept Rural Economic Prosperity Funding (REPF) totalling £128,333 from the East Midlands Combined County Authority and to agree the associated investment plan.

### **REPORT DETAILS**

#### 1. <u>Background</u>

- 1.1 The Government's prospectus for UK SPF 2025/26 issued in January 2025 stated that EMCCA would be lead authority for UKSPF and would receive the region's allocation of funding for 2025/26.
- 1.2 The EMCCA Board meeting in February 2025 confirmed that delivery of some of the funding received by EMCCA would be delegated to the non-constituent Councils i.e. Districts and Boroughs (i.e. a mixed model was agreed). This was for the UKSPF allocation, as set out in the 'UKSPF Report.'
- 1.3 UKSPF for the period 2022-2025 included for a separate grant fund of Rural Economic Prosperity Funding (REPF). The Government confirmed a further allocation for a 1-year period on 28 March 2025, with Bolsover District Council receiving a grant award of £128,333, with delivery commencing from 1 April 2025 through to 31 March 2026.
- 1.4 On 2 April 2025, EMCCA confirmed the allocation, and that it would be allocating the funding direct to the seven district councils (4 in Derbyshire and 3 in Nottinghamshire) to spend on local interventions. The investment plan proposals were to be completed and submitted to EMCCA by the close of play on 11 April 2025 to meet the deadlines of being able to submit a return to Government on both UKSPF and REPF.

1.5 As with the UKSPF timescales, it has been necessary to agree an investment plan at pace because of the date of this decision by EMCCA to allocate funding to the Council in relation to the time allowed to submit an investment plan to draw down the funding and commence activities as early as practicable in 2025/26 and complete those activities by no later than 31 March 2026.

## 2 Details of Proposal or Information

- 2.1 REPF aims to support the delivery of capital projects for small businesses and community infrastructure in rural areas, to improve productivity and strengthen the rural economy and rural communities.
- 2.2 The following table set out the details of the investment plan that has been submitted to EMCCA and the proposed delivery partners. It sets out a brief description of the activities that will be funded by the Council's allocation of REPF for the financial year 2025/26 and delivered from 1 April 2025 to 31 March 2026.

Glapwell Cricket Club Pavilion Building (Glapwell Colliery Cricket Club)	Installation of a disabled ramp and access improvements to the pavilion building, including new accessible toilet.	£35,000
Pinxton Community Hub (Dragonfly Management (Bolsover) Limited)	To produce RIBA Stage 2 drawings for the construction of a replacement community centre, to provide improved and accessible accommodation for community groups.	£53,333
The Anchor public house, Clowne (Clowne Parish Council)	To produce RIBA Stage 0-2 drawings and associated business plan for the construction of a community centre in a former public house building.	£40,000

## 3 Reasons for Recommendation

3.1 Accepting the funding is in the best interests of the District and by doing so, the Council will receive the funding and support local rural communities.

## 4 Alternative Options and Reasons for Rejection

4.1 No alternative options were considered reasonable due to the urgency to provide clarity on the investment plan to allow the Council to draw down its allocation of REPF for 2025/26. It can deliver a range of activities that meet the eligibility criteria within the timelines and those activities will stimulate social and economic regeneration for the District.

## **RECOMMENDATION(S)**

1. To accept the Rural England Prosperity Fund (REPF) totalling £128,333 from the East Midlands Combined County Authority.
