The Improvement Officer left the meeting during Minute No HEA31-20/21.

Also in attendance at the meeting was Councillor Nick Clarke (Portfolio Holder - Carbon Reduction Efficiencies) and Councillor Deborah Watson (Portfolio Holder - Environmental Health & Licensing).

HEA25-20/21 APOLOGIES

Apologies for absence were received on behalf of Councillor Peter Roberts.

HEA26-20/21 URGENT ITEMS OF BUSINESS

There were no urgent items of business to consider.

HEA27-20/21 DECLARATIONS OF INTEREST

There were no declarations of interest made.

HEA28-20/21. MINUTES

Moved by Councillor Tom Munro and seconded by Councillor Anne Clarke.

RESOLVED that the Minutes of a Healthy Safe Clean and Green Communities Scrutiny Committee held on 15th December 2020 be approved as a correct record.

HEA29-20/21 LIST OF KEY DECISIONS AND ITEMS TO BE CONSIDERED IN PRIVATE

HEA30-20/21 CORPORATE AMBITIONS PERFORMANCE UPDATE – OCTOBER TO DECEMBER 2020 (Q3 2020/21)

Committee considered a report in relation to the Quarter 3 outturns (October to December 2020) for the Council's Ambition Performance Framework 2020-2024 targets and relevant supporting service indicators.

The summary in the report explained that:

13 targets in total
8 targets were on track
1 target achieved previously (ENV 10)
4 targets had been affected by COVID-19

Service Indicators:

12 indicators in total
6 indicators had positive outturns
5 indicator had been affected by the COVID-19
1 indicator had a negative outturn

Councillor Tom Munro referred to the voids indicator (CUS.07 - Reduce average re-let times for standard voids to 20 calendar days by March 2021 and maintain thereafter) and hoped that this was a performance area Scrutiny Committees could continue to monitor closely. The Improvement Officer explained that he had flagged this area up to the Head of Property Services & Housing Repairs, and the Head of Property Services & Housing Repairs had replied he would be happy to attend a meeting of the Healthy, Safe, Clean and Green Communities Scrutiny Committee to answer questions on voids if requested.

Councillor Nick Clarke (Portfolio Holder - Carbon Reduction Efficiencies) referred to indicator ENV.01 (Develop an externally facing climate change communication strategy targeting communities and stakeholders by October 2020 and deliver an annual action plan) and the mention in the document of the Carbon Reduction Group having a meeting in January 2021, but he reported that the January 2021 meeting was postponed because of the latest COVID-19 lockdown and the next meeting was scheduled for 9th March 2021.

The Scrutiny & Elections Officer explained to Members some of the questions/requests asked about the indicators by the Chair and Vice-Chair during this meeting's pre-meeting were:

Corporate Ambitions

ENV01 – we're aware the planned CRG meeting was cancelled with the next one not until March. Is there anything else to update at this point?

HEALTHY, SAFE, CLEAN AND GREEN COMMUNITIES SCRUTINY COMMITTEE

ENV02 – Is it possible to get the final figures presented broken down so we can see the difference between buildings, fleet etc.?

ENV 03 – Concerned that the staff are permanently on catch-up for the red bin collections. The update notes ongoing staffing issues but it is to clear why they are not using additional agency staff to ensure service is being delivered. Aware that the online reporting system has had glitches when people are reporting to report non-collection. Members feel a response from Wards is required as to why collections are so off track. Members are aware that this is affecting all 3 districts in the contract. Has an assessment been made as to whether the contract is actually deliverable now Chesterfield BC collections are included, as this was not as much of an issue when it was only NEDDC/BDC?

CUS06 – What support is available for those at risk of eviction/homelessness during Covid? Are we able to intervene to stop the eviction/take preventative action or can we only support once actually homeless?

CUS07 – When reporting is it possible to distinguish between the discrete quarterly figure and the YTD figure? Furthermore the Target is specifically about standard voids – the figures should reflect this. It is suggested that should the service want to report against non-standard voids i.e. majors, this should be done under a separate target so both sets of data can be seen clearly. The commentary predominantly relates to major voids and capital schemes which is not what the target is about.

CUS08 – the status on track is misleading as this is a new target to both set up a monitoring system, and then track satisfaction levels. Would it better to split this in to two separate parts?

General ENV Health query

How are we managing those businesses that are running take away services? Do they require additional certificates? What are they required to do differently in relation to covid to be 'covid-secure'? How do we get a list of those businesses that are compliant so we can track things locally and be aware of businesses that haven't got the correct certificates/systems in place?

Councillor Nick Clarke responded to the points by stating that a Carbon Emissions report would be going to the Executive, and the bin collection issues were currently being addressed by Executive Members liaising with officers. The Chair thanked Councillor Nick Clarke for these responses as they had addressed some of the points, but the Chair stated he would still like the Joint Head of Street Scene to attend a future meeting to address them as well.

Councillor Deborah Watson (Portfolio Holder - Environmental Health & Licensing) provided more information for the bin collection issues by stating that they were being addressed and the Joint Head of Street Scene would be able to provide specifics, but there was no point in changing the bin collection indicators and targets right now because these were sure to change when the Government decided its upcoming guidance on COVID-19 secure bin collections. She added that no bin collections in the District had been completely missed – rather, some had been late and refuse workers had to catch up on them later.

HEALTHY, SAFE, CLEAN AND GREEN COMMUNITIES SCRUTINY COMMITTEE

Councillor Tom Munro asked if instances of late bin collections (and the reasons for them) had been properly communicated to residents. Councillor Deborah Watson explained that the reasons were outlined in In Touch magazine, and Communications officers were asked to display late collections on the Council website.

Councillor Deborah Watson explained that Environmental Health officers issued COVID-19 secure guidance to all businesses, and a number of inspections had been carried out.

Councillor Tom Munro referred to the sentence in the CUS.08 (Maintain high levels of tenant satisfaction with council housing and associated services) target which stated “we don’t capture customer satisfaction formally at present” and was concerned how this could be marked as ‘on track’ if there wasn’t a system in place to measure it.

The recommendation in the report was moved by Councillor David Downes and seconded by Councillor Anne Clarke.

RESOLVED that outturns against the Council’s Ambition 2020-2024 targets and relevant service indicators be noted.

(Information, Engagement and Performance Manager/Improvement Officer)

HEA31-20/21 SCRUTINY COMMITTEE WORK PROGRAMME 2020/21

N.B. The Improvement Officer left the meeting at this point.

Committee considered the Work Programme for 2020/21.

The Scrutiny & Elections Officer explained that attached to the Work Programme were two review scopes for Member approval: a Review of Council Policy on Sky Lanterns and Helium Balloons, and a Review of Council Policy on Fireworks.

Councillor Tom Munro asked if consultation with Parish Councils could be included in the consultation for the Fireworks review. The Scrutiny & Elections Officer stated that the exact targets of the consultation would be entirely up to Members once the review began.

Councillor Janet Tait asked if the Fireworks review could consider the Council using silent fireworks for its own displays. The Scrutiny & Elections Officer stated that the possibility of doing this would be investigated.

The recommendations in the report to note the Work Programme and approve the draft review scopes were moved by Councillor David Downes and seconded by Councillor Tom Munro.

RESOLVED that the Committee:

- 1.2 Section 19 of the Police and Justice Act requires every local authority to have a Crime and Disorder Committee with the power to review or scrutinise decisions made or other action taken in connection with the discharge by the responsible authorities of their crime and disorder functions. (Responsible authorities are effectively the statutory partners within a community safety partnership i.e. Police, local authorities (county and district), Fire and Rescue Authority, Probation Trusts and Clinical Commissioning Groups.)

- 1.5 Due to the sensitivity of some of the information being presented to Members, this item will be split across the Public and Exempt sessions of the meeting. The first part of the review will take place under item 7 of the agenda with the remaining elements of the review falling under item 9 in exempt session.

2 Conclusions and Reasons for Recommendation

- 2.1 Completion of the Annual Review of the CSP is required by legislation and this area falls within the remit of the Healthy, Safe, Clean and Green Communities Scrutiny Committee.

3 Consultation and Equality Impact

- 3.1 All Scrutiny Committees are committed to equality and diversity in undertaking their statutory responsibilities and ensure equalities are considered as part of all Reviews. The selection criteria specifically asks members to identify where the topic suggested affects particular population groups or geographies.
- 3.2 The Committee was consulted prior to the review to establish current issues and key lines of enquiry. Relevant officers were also approached prior to the review to ensure Members were fully briefed on current developments and service delivery during the pandemic.

Portfolio Holder for Community Safety and Partnership Chair

Welcome to the Bolsover Community Safety Partnership Plan covering the three years 2020 to 2023.

This plan sets out how Bolsover District Council, Police, Derbyshire County Council, Probation Services, Derbyshire Fire and Rescue Service, Derby and Derbyshire Clinical Commissioning Group together with voluntary and community sectors will work together with the communities of Bolsover district to reduce crime, disorder, anti-social behaviour, substance misuse and re-offending in order to keep Bolsover district a safe place to live, work and visit.

The Plan aims to reduce the number of crimes and anti-social behaviour in the district, but in some categories, it aims to increase the number of reports where historically victims have not felt confident enough to report it to us. By increasing reporting we will then be able to offer support to those victims and take appropriate action against the perpetrators.

23 Crime and disorder impacts not only the victims but also on the quality of life of the wider community so we understand how important it is for you that we tackle it in a timely, efficient and effective way.

We are confident that this Plan not only addresses the priorities that have been identified through our analysis of evidential information and performance but also the concerns of the people of Bolsover district.

We recognise that as a Partnership we have a duty and responsibility to continue to tackle crime and disorder which affect the safety and wellbeing of everyone who lives, works or visits our district.

2020 has been a challenging year for everyone. As a consequence of the Covid-19 pandemic, there are lots of ways it has changed situations for people. During the lockdown periods, vulnerable people may not have had so many opportunities to be seen, identified or supported by protection or supporting services. This is the same for children who witness domestic abuse and can only access support when the schools are open.

However, with more people being at home, less people are going out to the restaurants/pubs and with less travel in general, this has given less opportunity for acquisitive crime which has seen a significant reduction across the county.

Our continued aim is to work together promoting community safety, protecting the vulnerable and making Bolsover district a safer place for everyone to live and work.

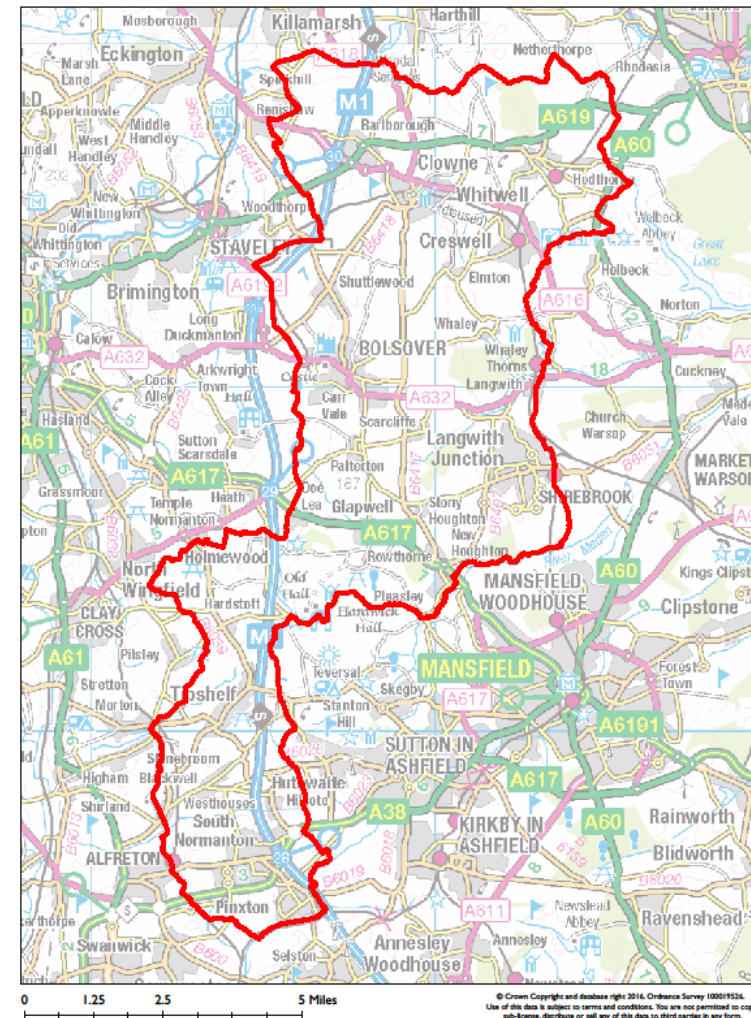
Bolsover District

Bolsover district is situated to the east of Derbyshire with its borders on the Peak District and Sherwood Forest. Bolsover town has a significant amount of historical importance with the main tourist attraction being its 17th century castle built by the Cavendish family and visited by thousands of people each year. The M1 Motorway runs through the district providing a transport connection to the rest of the country.

The district has four medium sized towns; Bolsover, Shirebrook, Clowne and South Normanton. These towns are part of urban areas which provide a range of facilities, services and employment opportunities to the surrounding areas. A significant proportion of the population of the district live within the 4 main towns. Outside the market towns there are scattered farms and small villages in a mostly open rural landscape punctuated by compact settlements.

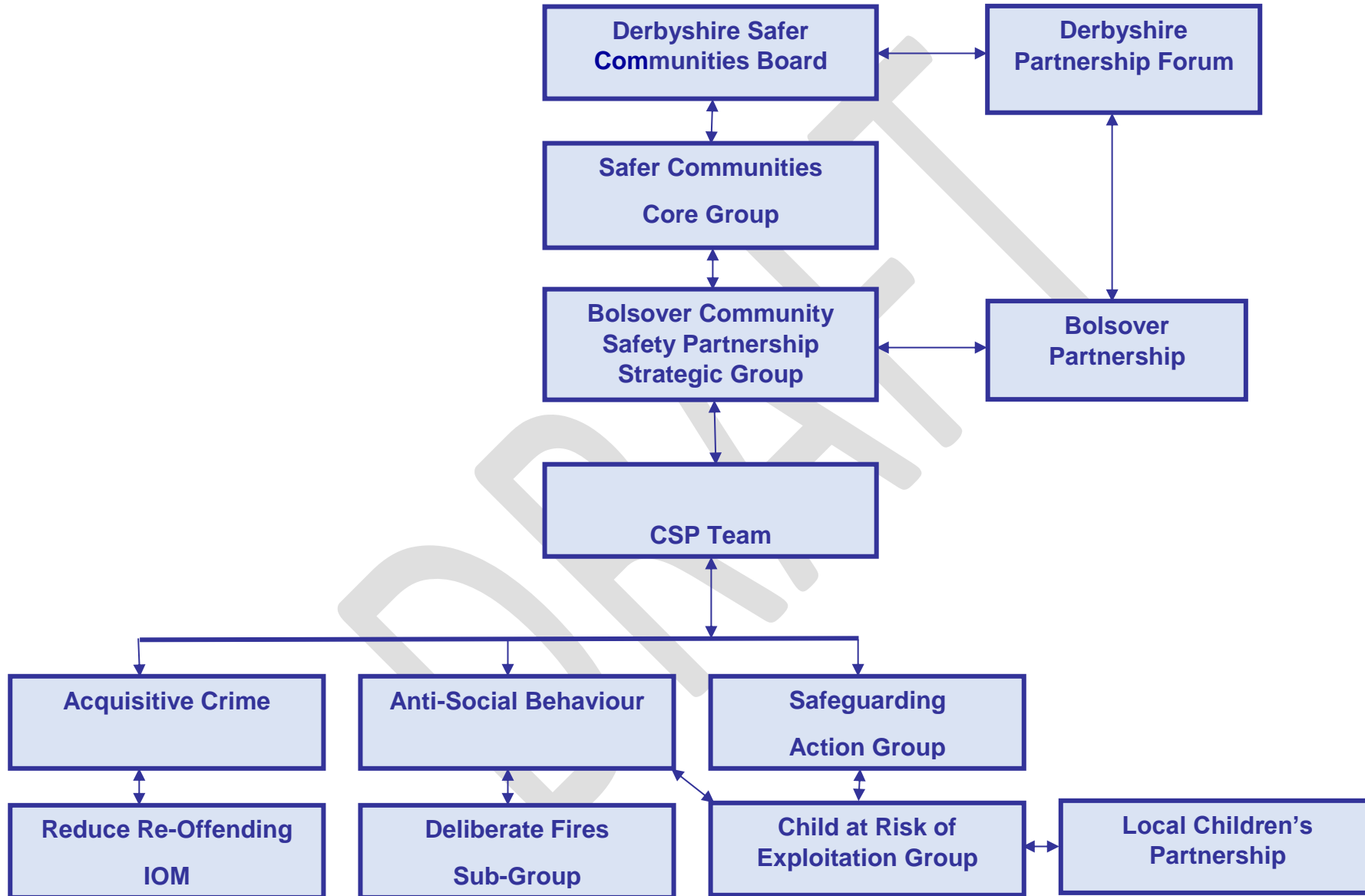

Levels of Recorded Crime

All Crime

Recorded crime in Bolsover district increased by 27% between January-December 2018 and January-December 2019.

However, between January-December 2019 and January-December 2020 the district saw a slight decrease by -0.2% in recorded crime with significant reductions in All Burglary (-37.2%) Shoplifting (-53.4%) and Theft from motor vehicle (-39.1%).

During the last 12 month period, the district has seen the largest increases in Violence without injury (32%) and Public disorder (47.6%).

Anti-Social Behaviour (ASB)

Recorded anti-social behaviour (ASB) incidents have shown a downward trend, falling by -13.3% between January-December 2018 and January-December 2020.

27 Between January and December 2019 there were 2352 ASB incidents recorded to the police, which is a decrease of -21.6% when compared to the same period of the previous year.

However, between January and December 2020, there were 2602 incidents of ASB recorded, which is an increase of 10.6% compared to the same period in the previous year.

During April, May and June there was a significant increase in ASB calls for service and a further rise can be seen from October onwards. It should be noted that any breaches of COVID related calls are classed as ASB.

No applications for Community Trigger reviews in relation to ASB were received in Bolsover in the 12 month period to March 2021.

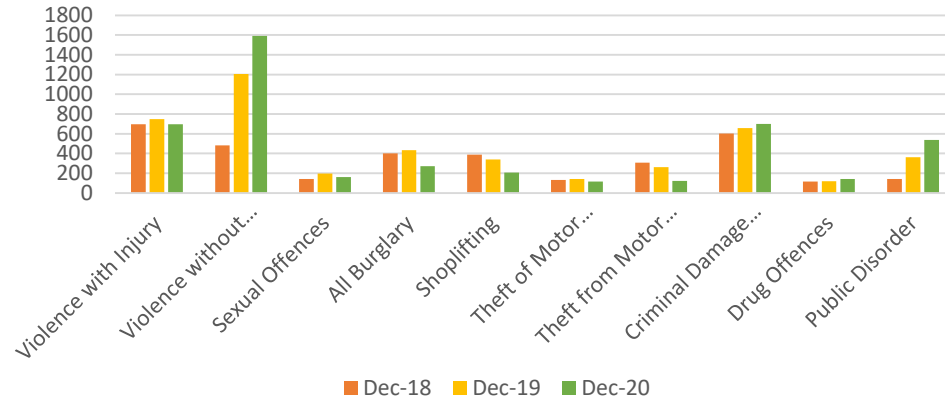

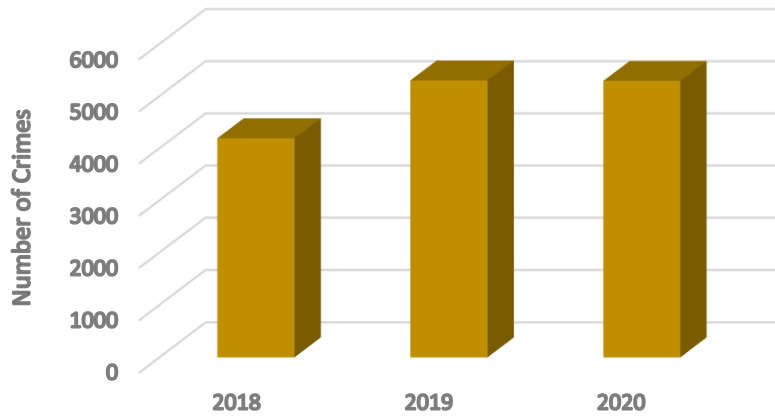
Recorded crime over the past 3 years

12 months to December**

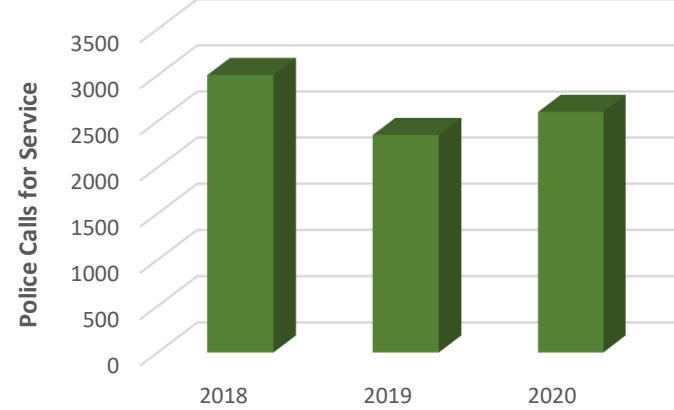

12 months to December**

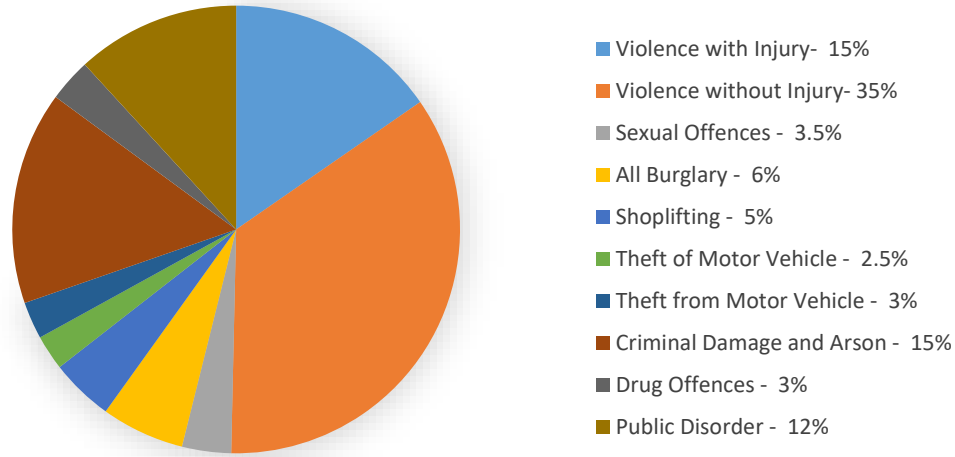


**Anti- Social Behaviour
12 months to December**



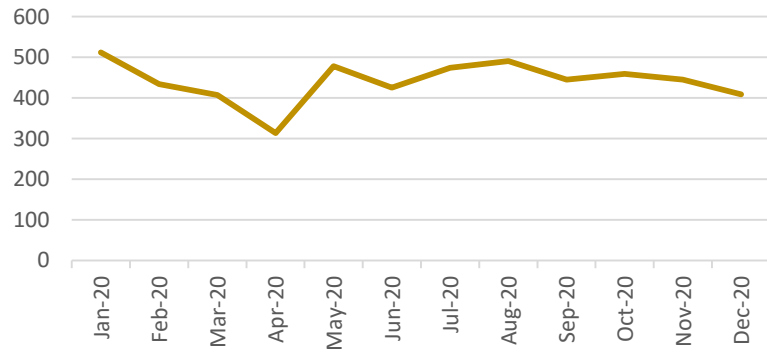

Types of crime in 2020

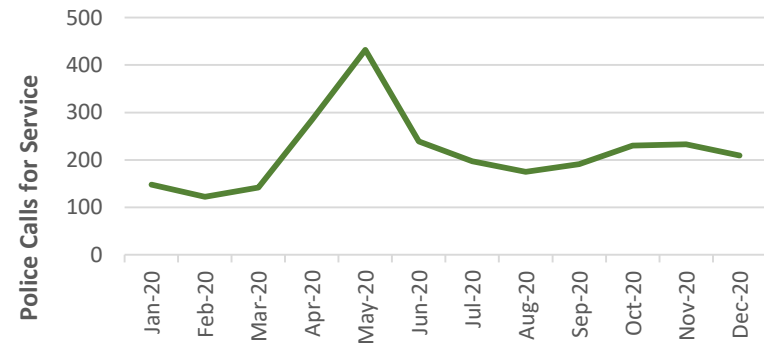

Derbyshire Safer Communities Board Joint Strategic Risk Assessment

Since the last agreement there have been many changes both locally and nationally, but effective partnership working remains vital to the ongoing success in tackling crime, anti-social behaviour and substance misuse across Derbyshire.

For a number of years the Derbyshire Safer Communities Board has been at the heart of these partnership arrangements. But this is not without its challenges, significant pressures on public sector funding is affecting all Responsible Authorities, in addition the need to be respond to a number of new and emerging strategic responsibilities provide a real impetus to work in a more focused and smarter way.

Over the last couple of years, the Board has worked hard to ensure it has the right structure to be responsive and meet these challenges.

The Board has identified its priorities for 2020 – 2023 through a joint strategic threat and risk assessment.

An annual risk and threat assessment is carried out by Derbyshire Constabulary jointly with its community safety partners.

Priorities

There are a number of **long standing priorities**, which the Board will continue to support. These are priorities for which there is a strong structure in place to oversee delivery and to identify and address gaps in provision. It is acknowledged that investment in these priorities needs to be maintained in order to ensure performance is sustained and identified areas for development are progressed. These are;

- Domestic Abuse and Sexual Violence
- Anti-Social Behaviour
- Modern Slavery
- Prevent (Counter Terrorism)
- Hate Crime

In addition to these a two **development priorities** have been identified. These are;

- Organised Crime, including County Lines
- Serious Violence

It needs to be acknowledged that in relation to the developmental priorities, the Board needs to focus on the aspects of their delivery which fall within its remit. To that end, it will be critical that the Board works with the other Strategic Boards to ensure a comprehensive response is achieved.

In delivery of the priorities outlined above, there should be specific focus on;

- Prevention and Early Intervention
- Data and Information Sharing

Bolsover Community Safety Partnership Priorities

The Partnership Plan must set out priorities to reduce crime and disorder in the area. This current Plan covers a 3 year period to 2023, and will be refreshed annually.

To inform this Plan a comprehensive strategic assessment was completed which has provided us with an analysis of community safety issues within the district together with previous performance.

We consulted on the findings of the assessment with all our partners to ensure we have correctly captured and analysed the problems in the district

We have linked its aims and objectives to reflect our joint priorities so we can utilise our resources more effectively and work together to reduce the fear of crime and disorder and increase community safety within our communities.

The Plan brings together our vision, aims and priorities for making Bolsover district safer.

Bolsover Community Safety Partnership has a statutory responsibility in relation to Modern Slavery, Domestic Homicide Reviews and Serious Violence which will influence its work throughout the duration of this plan.

Bolsover Community Safety Partnership has identified the following local priorities which will be its focus for 2020-2023.

Definitions

Acquisitive Crime

Acquisitive crime is defined as: crimes of robbery of business property; robbery of personal property; burglary in a dwelling; burglary in a building other than a dwelling; theft of vehicle; theft from vehicle; interfere with vehicle; theft from the person; bicycle theft; shoplifting; and all other theft offences. Although some types of fraud can be a type of acquisitive crime, all types of fraud are included within the definition of economic crime and are excluded from acquisitive crime.

Anti-Social Behaviour

Under the Anti-Social Behaviour, Crime and Policing Act 2014, anti-social behaviour is defined as:

- "conduct that has caused, or is likely to cause, harassment, alarm or distress to any person;
- conduct capable of causing nuisance or annoyance to a person in relation to that person's occupation of residential premises; or
- conduct capable of causing housing-related nuisance or annoyance to any person".

Examples of anti-social behaviour include:

- Verbal Abuse,
- Graffiti and vandalism,
- Noise nuisance,
- Alcohol and drug related disorder,
- Vehicle related nuisance,
- Threatening or intimidating behaviour by individuals or groups.

Cyber Crime

Cyber-crime is defined as: those crimes committed, in full or in part, through a computer, computer network or other computer enabled device (e.g. a smart phone, tablet device, or gaming device). They can be either:

- Cyber-dependent crimes – those that can only be committed using computers, computer networks or other forms of information communication technology, including the creation and spread of malware, hacking to steal personal or industry data, and denial of service attacks.
- Cyber-enabled crimes - those where the online environment is used in the commission of the offence.

Domestic Violence and Abuse

Domestic violence and abuse is defined as: any incident or pattern of incidents of controlling, coercive or threatening behaviour, violence or abuse between those aged 16 or over who are or have been intimate partners or family members regardless of gender or sexuality.

The abuse can encompass, but is not limited to: psychological; physical; sexual; financial; emotional.

Controlling behaviour is a range of acts designed to make a person subordinate and/or dependent by isolating them from sources of support, exploiting their resources and capacities for personal gain, depriving them of the means needed for independence, resistance and escape and regulating their everyday behaviour.

Coercive behaviour is an act or a pattern of acts of assault, threats, humiliation and intimidation or other abuse that is used to harm, punish, or frighten their victim.

Economic Crime

Economic crime is defined as: any non-violent crimes that result in a financial loss, with the exception of those included in the definition of acquisitive crime. These crimes thus comprise a broad range of illegal activities, including bribery, corruption, counterfeit currency, fraud, money laundering, and tax evasion.

Killed and Serious Injury Road Collisions

Killed and serious injury road collisions are defined as: collisions where any casualty sustains injuries which are classed as either fatal; life threatening (where there is a high probability of death); life changing (where there is a high probability that the injured party will not recover sufficiently to lead an independent life); or serious (where the injury is less than life changing but amounts to a s20 Grievous Bodily Harm injury).

Modern Slavery

Modern slavery is defined as: a complex crime that encompasses slavery, servitude, forced and compulsory labour and human trafficking. Traffickers and slave drivers (often Organised Crime Groups) coerce, deceive and force individuals against their will into a life of abuse, servitude and inhumane treatment.

Offender Management

Offender management is defined as: the integrated offender management (IOM) scheme, which targets offenders of most concern to their communities. The scheme uses pooled, local resources to turn offenders away from crime, supporting them to find employment and somewhere to live, and punishing and reforming them as appropriate.

Organised Crime Groups

Organised crime groups are defined as: groups of two or more people who engage in continuing serious organised criminality. Their motivation is often, but not always, financial gain.

Safeguarding Adults

Safeguarding adults is defined as: protecting an adult who has needs for care and support, and is experiencing, or is at risk of abuse or neglect, and as a result of their care and support needs is unable to protect themselves from either the risk of, or the experience of abuse or neglect.

An adult is a person who is 18 years of age or older.

Hate crime is defined as: any incident which constitutes a criminal offence, perceived by the victim or another person as being motivated by prejudice, hate or intolerance on the grounds of disability, ethnicity, gender identity, religion, sexual orientation, or alternative sub-culture.

Safeguarding Children

Safeguarding children is defined as: the process of protecting children from abuse or neglect, preventing impairment of their health and development, and ensuring they are growing up in circumstances consistent with the provision of safe and effective care that enables children to have optimum life chances and enter adulthood successfully. A child is a person who is under the age of 18 years.

Child abuse is defined as: any form of maltreatment of a child. This can be physical, sexual or emotional abuse and / or neglect.

Child sexual abuse is a form of child abuse and is defined as: forcing or enticing a child or young person to take part in sexual activities, whether or not the child is aware of what is happening.

Children at Risk of Exploitation (CRE). Exploitation occurs where an individual or group takes advantage of an imbalance of power to coerce, manipulate or deceive a child into sexual or criminal activity; (a) in exchange for something the victim needs or wants,

and/or (b) for the financial advantage or increased status of the offender or facilitator. The victim may have been sexually or criminally exploited even if the activity appears consensual. Child exploitation does not always involve physical contact; it can also occur through the use of technology.

Sexual Violence

Sexual violence is defined as: any behaviour perceived to be of a sexual nature which is unwanted and takes place without consent or understanding.

Section 74 of the Sexual Offences Act 2003 defines consent as: if he agrees by choice, and has the freedom and capacity to make that choice.

Child sexual exploitation is dealt with under the Safeguarding Children topic, as the majority of cases relate to indecent images of children which are not counted under the sexual offences crime category.

Substance Misuse

Substance misuse is defined as: the short-term and long-term damage to health associated with the consumption of alcohol and / or illicit drugs (i.e. substances that affect bodily functions which are controlled by legislation) and the resulting damage in the form of crime and disorder arising from the consumption of alcohol and the production, trade and use of illicit drugs.

Terrorism and Domestic Extremism

Terrorism is defined as: the unlawful use or threatened use of force or violence against individuals or property in an attempt to coerce or intimidate governments, organisations or the public to achieve political, religious, racial or ideological objectives.

Domestic extremism is defined as: the activity carried out by individuals or campaign groups who carry out criminal acts of direct action in furtherance of a campaign.

These people usually seek to prevent something from happening or to change legislation or domestic policy, but attempt to do so outside of the normal democratic process.
