We would very much appreciate an extension of six months, one day per month of Nick's time to ensure the groups longevity and success. Please may we have a conversation to see how we may extend Nicks time with us" The Business Forum Co-ordinator has overcome barriers and built trust amongst business owners; in a small community, personal trust based on shared experiences is key for cooperation.
