Review of the Council's Policy under the Gambling Act 2005

PURPOSE / SUMMARY

To consider renewal of the Council's Policy under the Gambling Act 2005

REPORT DETAILS

- **1 Background** (reasons for bringing the report)
- 1.1 Under The Gambling Act 2005, the Council is responsible for issuing premises licences for casinos, bingo halls, betting offices, adult gaming centres and licensed family entertainment centres as well as permits for gaming machines in pubs, clubs and other alcohol licensed premises.
- 1.2 The Act contains three licensing objectives, which underpin the functions of the Gambling Commission and the local authority, acting in their capacity as the licensing authority. These objectives are central to the regulatory regime created by the Act and are:
 - preventing gambling from being a source of crime or disorder, being associated with crime or disorder, or being used to support crime;
 - ensuring that gambling is conducted in a fair and open way; and
 - protecting children and other vulnerable persons from being harmed or exploited by gambling;
- 1.3 The Gambling Act 2005 imposes a statutory requirement upon Bolsover District Council, as the statutory Licensing Authority to prepare a Statement of Principles (alternatively referred to as a policy). This is the Councils tool in regulating gambling in the district, it sets out what the Councils expectations are as to how operators should behave, and ensures the general public and Responsible Authorities are aware as to how the Council approaches Gambling Regulation.

- 1.4 The Gambling Act 2005 (Licensing Authority Policy Statement) (England and Wales) Regulations 2006 set out the requirements for the form and publication of the policy which the Council proposes to apply when exercising its functions under the Gambling Act 2005.
- 1.5 In 2018 an extensive review was undertaken to ensure that the Council's policy was consistent with statutory guidance and in a format common to neighbouring authorities to enable consistency and transparency. The policy, together with a Local Area Profile was published on 31 January 2019. The Act requires the Council to republish its policy every three years, at least four weeks before the previous policy expires, and to review the policy in full every three years.

2. <u>Details of Proposal or Information</u>

- 2.1 The current policy is to be republished by the 3rd January 2022, however a full 12 week public consultation on a new policy is required as part of the Council's obligations to review its policy every three years.
- 2.2 The internal review of the existing policy has identified a number of minor consequential amendments in the statutory guidance which need to be made to the existing policy as well as local demographic and business data. These changes are not a modification to the content of the policy, simply an update to references within the document.
- 2.3 Over the last three years there has not been a significant change in the types of premises in the district with 70 gambling premises in comparison to 83 premises in 2018. The businesses are broken down into the following:

Adult Gaming Centre Premises Licences	4	6

Gambling Prize and Machine Permits	60	68

- 2.4 Since the previous policy was published there has been a 27% reduction in the number of Small Society Lotteries registered between 2018 and 2021 from 72 to 53. It must be noted that some reductions may be temporary and due to the wider impact of the Coronavirus pandemic.
- 2.5 The new draft policy is in Appendix 1, the updated Local Area Profile is in Appendix 2 and the consequential amendments described in full in Appendix 3.
- 2.6 In order to continue to comply with the Council's obligations under the Gambling Act 2005 the current policy will be republished four weeks prior to its expiry on 31 January 2022. However, to enable the updates outlined in this report a full consultation will be carried out with a view to publishing the revised policy at a later date.
- 2.7 The next steps are for the draft policy and Local Area Profile to be considered by the Licensing and Gambling Acts Committee, be subject to a 12 week public

consultation and a further decision by the Licensing and Gambling Acts Committee and then Council for adoption.

3 Reasons for Recommendation

3.1 The Council is required to prepare and publish a Statement of Principles under the Gambling Act 2005 every three years.

4 Alternative Options and Reasons for Rejection

4.1 The Council can choose not to prepare and publish a new Statement of Principles; however this would leave the authority open to successful legal challenge by way of appeal against decisions on licensing matters or judicial review.

RECOMMENDATIONS

Staffing:

- 1. The Committee notes the intention to republish the current policy four weeks prior to its expiry date; and
- 2. The Committee notes the revised draft Statement of Principles under the Gambling Act 2005 and the intention to carry out a public consultation on a new statement to be published in 2022;
